Important information:

- We do require a copy of the Childs Birth Certificate, Baptism Certificate and for those wishing to receive the Sacrament of First Eucharist, you will need to provide a copy of the child's confirmation certificate (if they were not confirmed in this Parish).
- At least one parent needs to be a Catholic, we do require a copy of their Baptism certificate, please.
- We also ask that the Sponsor for your child is Catholic. A copy of their Baptism Certificate, please.

The fee for the Sacramental Program 2024 is as follows:

- Confirmation only \$50
- First Holy Communion only \$50
- Both Confirmation and First Holy Communion \$100
- Photographer \$10

The payment of this fee will secure your booking and covers the resources provided for the Sacramental Program. These resources include a workbook educating the children about each sacrament, as well as prayer cards, a candle, rosary beads, and a certificate, which the children will be given when receiving the sacraments. This cost also contributes towards the administration costs to the parish.
